Highest Accreditation Standards Attest To Thomas Edison State College Quality

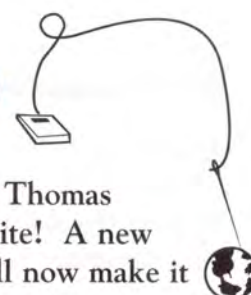

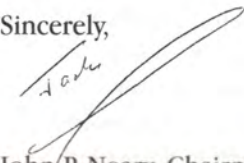

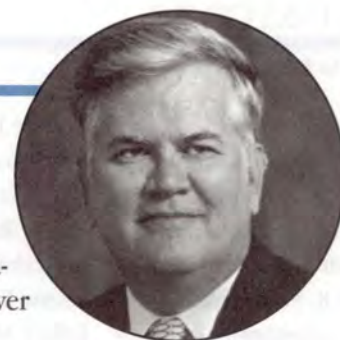
