# Thomas Edison State College's Division with a Mission

It's noontime, but the stack of papers on the chair in front of Dr. Nat Caliendo's desk are hardly noticeable to a man who hasn't sat down yet that day.

Five months into his new position as vice president for Public Affairs at Thomas Edison State College, Dr. Caliendo is spending a great deal of his time on the road meeting the College's many constituencies: business and community leaders, alumni and students, politicians and other friends of the College. When he is in the office, he can be found darting from one office to another, directing the efforts of a staff that collectively has responsibility for the external relations of the College.

As vice president for Public Affairs, Dr. Caliendo also serves as the executive vice president of the Thomas Edison State College Foundation, a role for which he has amassed

quite an admirable record of experience and achievement in previous positions. During his five years at the University of Rhode Island, for example, support from foundations and corporations increased over 1,400 percent, and assets of the University of Rhode Island Foundation climbed from just under \$3 million to a level of over \$9 million. At Rhode Island, he developed comprehensive marketing and fund-raising plans for all functional areas of advancement, including capital programs, the annual fund, planned giving, corporate and foundation relations, athletic fundraising and special events.

"I was attracted to Thomas Edison because of its unique mission of serving adult learners, the outstanding reputation of its president and the quality and commitment of the College's faculty and staff," Dr. Caliendo stated. He is especially impressed with the alumni and Foundation leadership, whom he says play "an important role in the vitality of this institution.

"We are doing wonderful work here at Thomas Edison," he emphasized, "but we need to more effectively communicate to others the important role we play in adult education in this country." He pointed to the growth of the College's Center for Corporate and Public Partnerships, the National Institute on the Assessment of Experiential Learning and the pioneering work of the Directed Independent Adult Learning office in developing techniques to deliver distance education to adult learners as examples where Thomas Edison's leadership is well recognized.

"It is equally important to communicate our *needs* as well as our accomplishments," Dr. Caliendo stressed. He explained that, with a tight state budget and a faltering economy, it is essential for the College to look to its friends (alumni, corporations and foundations) for the support necessary to grow in both scope and quality. The Alumni Association recently voted to establish

a \$5,000 endowment in the Thomas Edison State College Foundation and has pledged to add a minimum of \$1,000 to the Foundation each year. "It is their legacy to the institution that helped fulfill their dream of a college degree," Dr. Caliendo said. He explained that "one of our goals is to increase the endowment so that the College can consistently and predictably plan for its future growth."

Another goal Dr. Caliendo has is to expand the Foundation Board. "We have an outstanding Board, and we hope to increase it with persons of stature and influence; people who are committed to our mission and to helping us meet our fund-raising goals and objectives," he said. "The fact that we are attracting Foundation Board members of such high stature already illustrates that our mission is respected and appreciated."

In the short time since he has been at the College, he has lead the Division of Public Affairs in developing a comprehensive plan directed to operational goals and objectives, and to finding financial support for a number of priorities. "These priorities build upon the College's five-year plan and rely

### Emmy Winner is One of Our Own

For Emmy-winning Thomas Edison alumnus Larry LaSota, the path to a college degree began with a little ad in the *Newark News*. "I wanted to make use of all the college credits I had accumulated through the years," said LaSota in a recent telephone interview. "I was enrolled in St. Francis College in Pennsylvania, but left in the middle of the year, and I wanted to make my parents proud by finishing my degree."

LaSota describes his college career as that of a "drop-in" student. In his line of work he had to travel, and getting an education meant attending various colleges and universities around the country. Some of the institutions he attended, in addition to St. Francis, were Arizona State, Seton Hall, and New School of Social Research. Although he never visited the "campus" at Thomas Edison State College in Trenton, he became a member of the first graduating class by having enough

credits transferred from other accredited colleges and universities to complete an associate degree in 1973.

LaSota has a very interesting career background. He got into his current occupation in a way that, interestingly enough, resulted in his leaving college. He was working at a college radio station when he was thrust into the sound business. "I was sort of forced into sound mixing," he explained. "One day the mixer for the band didn't show up, someone told me I could do it and I did. I literally left school with the Guess Who [a popular music group at the time]."

Over the years, LaSota has traveled with bands such as Johnny Winters, The Birds, Edgar Winters, Buddy Miles, John Sebastian and many others. His talents also earned him work in the television industry. He has worked on shows such as "Family Ties," "Major Dad" and "Doctor, Doctor," and is currently the production mixer for "Designing Women."

These are just a few of the shows he has to his credit. He has seen many

things happen behind-the-scenes on TV shows, and explained how the attitude of the cast is "very catching." He spoke of how the ad libs of the cast on the set of "Doctor, Doctor" improved the show. LaSota also spoke warmly of the current cast of "Designing Women."

Television awards the Emmy to those who are voted, by their peers, outstanding in the field—LaSota has one to his credit. In 1986, he received the award for his work on the special "Mr. Previn Comes to Town," a classical special starring Andre Previn. He was also nominated for another Emmy for "Designing Women." *Prosound Magazine* gave him an award for his work on the special "Liberty Weekend" in 1986.

heavily upon the support of our friends if they are to be fully implemented," Dr. Caliendo pointed out. "The price tag to meet these needs is substantial and will require extraordinary efforts from Development staff, and the participation of alumni and Foundation Board directors."

When this high energy, highly motivated man does take a minute to sit down in his office, he is just as eager to talk about his four children—Nat, Danny, Christopher and Nicholas—as

he is about the College. Photographs of his children and his parents are all over his office, making it look more like a living room than one might expect. "I spend a lot of time here. I want to be surrounded by reminders of the people I care the most about," he says fondly, pouring himself another cup of coffee.

It is no secret among staff that he is also fond of his Italian heritage. He has been known to brag about the fine manicotti he makes "from scratchthere's no other way." Staff recently had a chance to sample it when he brought some in as his contribution to an office party.

His best "can you top this?" story is about how he spent his first weekend in Trenton. "I used a tankful of gas driving around the 'Burg' (Chambersburg, the Italian section of Trenton, known for its fine restaurants), checking out the neighborhoods and restaurants," he recalled. "In fact, I was actually

stopped by a policeman who wondered if I were lost. After all, I had out-of-state license plates!"

No longer a stranger to the Burg or its cuisine, Dr. Caliendo can be seen meeting with donor prospects over a fine antipasto in this ethnic section of the city. He already has some favorite restaurants, but, as would be expected from this experienced public affairs vice president, he refused to single out any one restaurant and recommend it.

# The Alumni Association Board:

#### Who they are and what they do for you

You are a member of a large, active and important organization by virtue of your Thomas Edison State College alumni status. Whether you received an associate or baccalaureate degree, your graduation from the College was your induction into the Alumni Association.

One of the goals of the Alumni Association, which receives 10 percent of the net proceeds of the Alumni Annual Fund in order to operate, is to get alumni involved with the College through various activities. These activities are planned by a volunteer Board of Directors and its officers. A hard-working group, the Alumni Board of Directors is responsible for the Alumni Annual Fund Phonathon, including participation in the Pre-Phonathon to call for volunteers. This is a fun and rewarding activity. Alumni get to met each other and speak to other alumni while phoning. The money raised helps the College purchase equipment, provide scholarships and meet other goals and priorities.

The Alumni Board also participates in Commencement activities such as assisting graduates with their caps and gowns. This is a big day for the graduates, and one of the few times the alumni can get together to meet and share experiences.

There are 26 officers and directors. Officers are the president, president-elect, vice president of development, vice president of alumni member relations, vice president of programs, secretary, treasurer and immediate past president. These positions are one year terms. To ensure that there are experienced members serving at all times,

there are nine directors positions that are never open at the same time. Five are open one year, followed by four open positions the next year. Directors serve for two-year terms. In addition, nine associate directors serve in oneyear, nonvoting positions.

Thomas Edison wants you! To become a member of the Alumni Board, an alum should submit a resume, along with the nominating form mailed to all alumni in the late spring. Interested alumni can also attend alumni events and speak to Board members about becoming candidates. All applications are reviewed by the Nominating Committee, and interviews are conducted. It is important to remember that to be a member, you must be available to attend six Board meetings per year, become active on at least one committee as well as participate in the Alumni Annual Fund Phonathon.

Interested in finding out more, but don't have the time for a Board position? Alumni can become involved through committee memberships, which are not limited to Board officers or directors. Committees which meet throughout the year include: Finance, Newsletter, Nominating, and Graduate Relations. Short term committees with fewer meetings include the Alumni Annual Fund Phonathon, and Commencement/ Banquet. While committees exist to benefit the College, socializing and fun are always on the agenda. The new friends and business connections that can be realized are more than worth the time invested.

- Q. You were instrumental in developing and implementing the first alumni community service project. Tell us about the Odyssey of the Mind Project.
- A. The Alumni Association will be working with an elementary school in the city of Trenton to initiate our first community service project. Odyssey of the Mind is a program that works for students from Kindergarten through college and offers them an opportunity to participate in challenging and motivating activities both inside and outside their regular classroom curriculum. The Odyssey of the Mind project should make learning fun, not only for the elementary school students, but also for our alumni who will be involved with the program.
- Q. If alumni are considering becoming involved in activities, such as Commencement or the Phonathon, then what can they expect by becoming involved?
- A. During Commencement, alumni are always there to help the new grads on their special day. Just before the ceremonies, some of us help the new grads suit up in the caps and robes. We greet them and introduce them to other graduates and alumni. After graduation, we travel to the banquet hall and share jobs of preparing reservations and table placements, arranging for social hour, preparing the program for the evening and keeping the new grads comfortable and happy.

The Phonathon is a two-week event held in April each year that is part of the College's Annual Fund program. For the first time ever, it will also be held a second time in November of this year. It requires a lot of planning and work, and we need people who will dedicate their time to helping us reach our thousands of fellow alumni and students of Thomas Edison State College. A pre-Phonathon session is held to recruit callers to help us make the calls during the Phonathon. The volunteer callers come to the College to make the telephone calls. It is work, but it is also fun and entertaining. We are, of course, elated when we see the total scores of all the money we raise to support scholarships, new programs, new technologies and facilities that accommodate student and College needs.


