### Commitment to Excellence

Institutional Lunch and Learn Demystifies the MSCHE's Self-Study Accreditation Process and Purpose

or colleges and universities, regional accreditation is an acknowledgement of the highest standard for

excellence in education in the U.S. It is the process by which higher learning institutions demonstrate a dedication to providing the best practices in the industry.

At Thomas Edison State College, those qualities are at the very core of its mission and the upcoming Middle States Commission on Higher Education (MSCHE) Self-Study offers the perfect forum to demonstrate the College's commitment to those ideals.

Accredited in 1977, the College has participated in the

Self-Study evaluation for reaccreditation every 10 years, a process that Provost and Vice President William J. Seaton and Executive Vice Provost Mary Ellen Caro clarified during the Jan. 20 Lunch and Learn in Prudence Hall.

"The Self-Study is aligned with our institutional commitment to assessment and ongoing quality improvement," said Caro, chair of the MSCHE Self-Study Steering Committee, which oversees the process. "The Self-Study provides us with an opportunity to demonstrate compliance with the MSCHE Standards of Excellence and our culture of assessment."

The MSCHE is the unit of the Middle States Association of Colleges and Schools that accredits degree-granting colleges and universities in the Middle States region. It is a voluntary, nongovernmental, membership association that defines, maintains and promotes educational excellence across institutions with diverse missions, student populations and resources.

"The Middle States Commission on Higher Education accrediting team will be focusing on its number one priority, student learning outcomes," said Seaton. "The review team will want to see concrete results of our learning outcomes efforts and how the College plans to maintain its commitment to continuous quality by demonstrating compliance with the Standards of Excellence. The Self-Study is an opportunity for the College to showcase its achievements."

The charge to the more than 90 attendees and the College community as a whole is to "get and stay involved." Suggestions for staff are to provide the committee with input during the process, to participate in community meeting such as the Lunch and Learn and the March 23 MSCHE visit, and to stay connected with the progress of the Self-Study.

## Holiday Spirit



# Focus On: Louise Riley

F or School of Nursing's Louise Riley, the seven-year itch is not part of the plan. Someone so dedicated rarely experiences such apathy.

Content to be approaching her seventh anniversary with the School of Nursing, what the assistant dean of Distance Learning enjoys most when comparing her years in healthcare with the ones now spent in academia, is the lack of constraint.

"What I like best about working for the College are the regular hours, no beepers on my nightstand, no weekend shifts and the wonderful people in the School of Nursing," noted Riley. "I am also impressed with the barriers the School and the College have removed for adult learners."



"I worked at the Hospital of the University of Pennsylvania (HUP) for 30 years, 23 of those years were spent in the surgical intensive care unit as a staff nurse, caring for patients immediately after major surgeries such as transplants, neurosurgery and open heart surgery," she said. "In 1995, I was asked to be on a task force to help deploy HUP's new electronic medical records system and later, I was given a position as an analyst in their IT department."

When she saw an ad for the position she would eventually fill at Thomas Edison State College, her interest was immediately piqued. The dean was looking for someone experienced in informatics and online education. The expectations, though challenging, would offer Riley an invigorating change.

"We are very pleased that Louise chose Thomas Edison State College," said **Dr. Susan M. O'Brien**, dean of the School of Nursing. "She brought knowledge of online education and technology to the School at a time when it was desperately needed. Since that time, Louise has displayed tremendous flexibility and the abil-

ity to expand her role to meet the School's ever-changing needs."

Her workdays now involve identification, recruitment, initial approval, orientation and clarification on policy issues for the School's approximately 80 nursing mentors. She handles mentor contracts, payments and course assignments; oversees the School's registration process; handles student grievances; co-authors articles for

publications; and acts as a liaison with the New Jersey State Library in ensuring that appropriate resources are available for the College's nursing students. Additionally, she assists with grant writing; administration of the current Health Resources and Services Administration grant; serves on College committees; and manages the course evaluation process as well as serving as a resource in technology-related matters.

Outside of the College, she serves as an adjunct instructor for Excelsior College and sits on that college's Curriculum Committee. Previously, she has also taught at Eastern University in St. Davids, Pa., the University of Colorado's Health Sciences Center and the University of Indianapolis.

As a student, Riley had the distinction of being the first online graduate from the University of Colorado's Health Sciences Center nursing program through which she now holds an MS degree in nursing informatics. Her board certification in that field places her among an elite group of only 500 nurses nationwide who claim the distinction. She received her bachelor of science in nursing degree from Villanova University in Villanova, Pa.

Riley lives in Bucks County, Pa., with husband Jerry an employee assistance program counselor with the U.S. Postal Service. The couple – both only children – has two daughters: Allison, a second career nurse currently earning her BSN at the College, and Jennifer, a gymnastics instructor and new mother. Jennifer, who also worked at Thomas Edison State College, was Rider University's first female pole vaulter, and still holds competitive records there. The Rileys also have a new grandson, Lucas.
