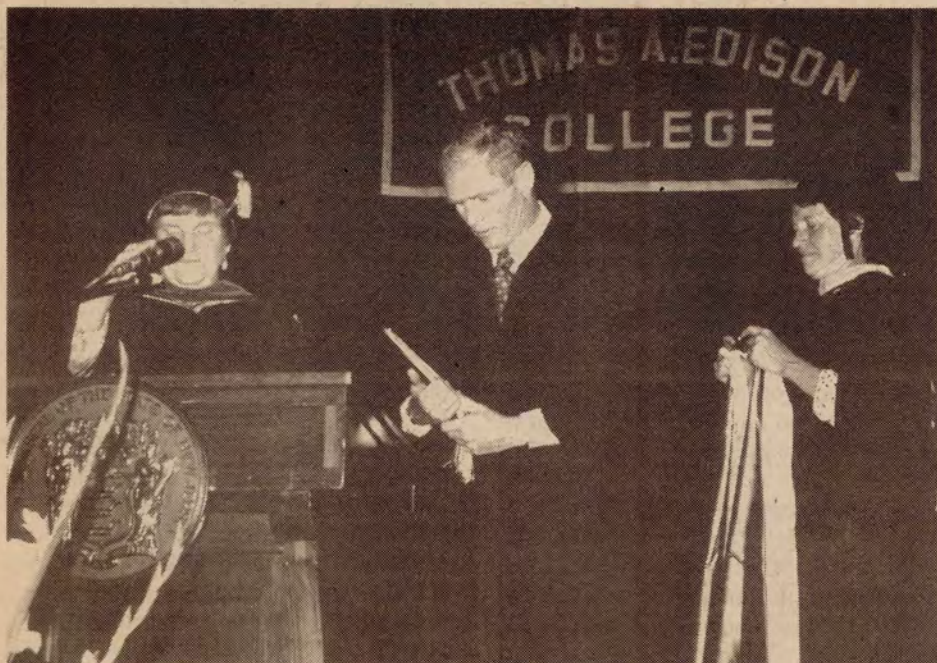

## Governor Byrne Delivers Commencement Address Receives First Edison Honorary Degree

Governor Brendan T. Byrne delivered the commencement address during the College's eighth annual graduation ceremonies on Sunday, September 28. As a part of the ceremonies, Byrne received the first honorary degree awarded by Edison State College.

"I hope that your degree will help you get a better job, just as I hope this degree you've awarded me today will help me get a better job in a year or two," a smiling Byrne told the graduates after receiving his Doctor of Humane Letters award.

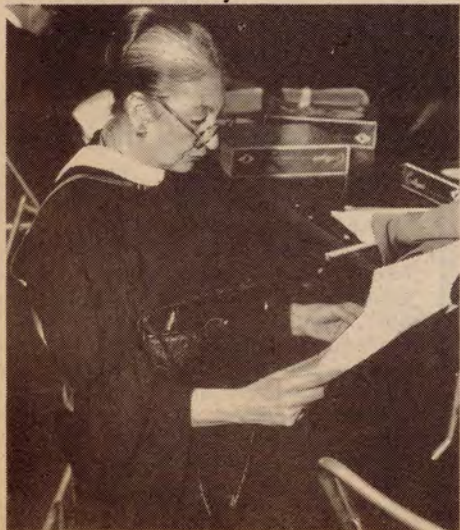
Byrne's second term as governor ends next year and he is barred by State law from running for re-election.

Byrne praised the work of the College and added jokingly, "At least Edison State College is one college that admits that they do not teach their students anything."

During the past year at Edison, baccalaureate degrees were earned by more than 250 adult graduates while nearly 200 mid-career adults earned associate degrees.

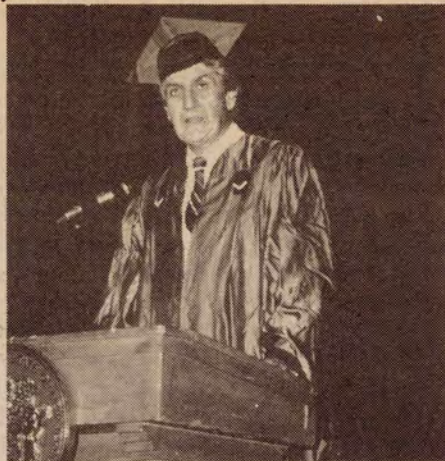
Typical of most Edison graduates was Patricia Tindall of Princeton. Chosen as the respondent for her fellow classmates receiving a bachelor's degree, Ms. Tindall noted "It had been a struggle to earn her degree, but well worth it."

The mother of three grown children, Ms. Tindall is currently a department administrator in art and archaeology at Princeton University.



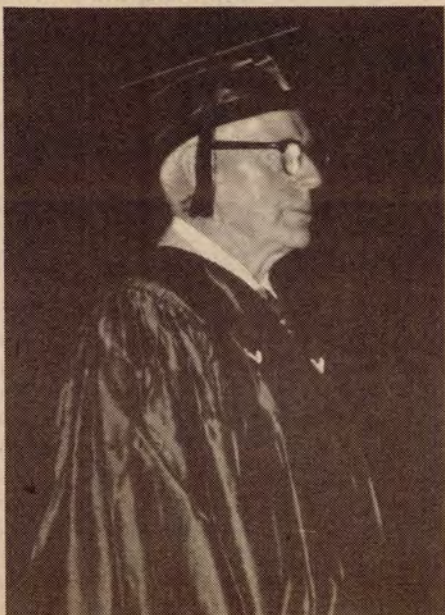

Robert Lynch, of Howell Township, spoke on behalf of the associate degree graduates. Lynch, the father of five children, ages 15 to 24, three of whom are also in college, is currently employed at Bergen County Community Action Program in an executive capacity. Lynch is well on his way to completing requirements for his bachelor's degree. He commented, "I'll be back to pick up that degree next year."

Albert Knowles of Clifton, who is 82 and is legally blind, was the oldest of the graduates who received their degrees during ceremonies at the War Memorial Building. Knowles said he hoped to return to the College next year to do additional work.

## Edison Receives Grants

Edison State College has received a \$41,000 federal grant from the Fund for the Improvement of Postsecondary Education. Announced by College president, Lorraine R. Matusak, the grant is for the establishment and development of a Statewide Testing and Assessment Center. A cooperative project by a number of New Jersey colleges, Edison will direct the day-to-day operation of the Center.

The Center will provide testing and assessment services for adults enrolled in the participating colleges. It will assist the student in preparing portfolios documenting prior learning. Faculty assessors then evaluate the documented learning and make credit recommendations to the Center which in turn sends grade reports to the students' home institution. The Statewide Testing and Assessment Center will also administer college level proficiency examinations.

In addition, State Chancellor, T. Edward Hollander announced that Edison College has been awarded a \$20,000 federal vocational grant for "Vocational Development for Selected New Jersey Civil Service Employees", and a \$22,000 grant for rental of a word processing system from the Department of Treasury's Management Improvement Unit.

## Art Fest '80 Postponed

Edison College's first annual Festival of the Arts, scheduled for September was postponed just prior to the September 7 opening.

The exhibit was to have been displayed in the first floor conference rooms of the Kelsey Building, and was to run from September 7 — the day of Trenton's State Street Stroll, to September 28 — Edison's Commencement date.

During the first week of September, the Governor's office insisted that the Casino Control Commission hold their license renewal hearings, for an Atlantic City based casino, in the Colleges conference rooms. Due to the lack of alternate suitable space for the art exhibit (See page 3 col 1)

Basic Skills

As mentioned in the last issue of INVENTION, students who enrolled at Thomas A. Edison State College with fewer than 32 credits are required by the New Jersey Board of Higher Education to take the New Jersey College Basic Skills Placement Test (NJCBSPT). This test is designed to assist you in making decisions about the kinds of courses you are prepared to take. It is not an admissions test. There is no charge for taking it. To take the test at a college near you, call the Test Administrator for the NJCBSPT at any of the institutions listed below.

Identify yourself as an Edison State College student, and request that you be allowed to take the NJCBSPT. Ask for a copy of the Information Booklet that gives further information about the test. If arrangements are satisfactory, be sure to put the Edison State College code number, 2748, on your answer sheet when you take the test. Your scores will then automatically be sent to us, and we in turn will send them to you.

If arrangements are not satisfactory, please contact Paul I. Jacobs, the Director of Test Development and Assessment, to arrange to take the NJCBSPT at Edison. You are required to take the NJCBSPT within two months of enrolling. If you have already taken the NJCBSPT at another institution, please fill out and return the form below to Dr. Jacobs.

PONSI

The Program on Non-collegiate Sponsored Instruction (PONSI) is a national program sponsored by the American Council on Education. Responsibility for this program in New Jersey has been assigned by the Department of Higher Education to Edison State College.

PONSI's mission is to help individuals get academic credit for learning which they have acquired outside the sponsorship of colleges or universities. PONSI evaluates and makes credit recommendations for formal educational programs and courses sponsored by non-collegiate organizations whose primary function is not education but who offer courses to their employees or members. These non-collegiate organizations include business and industry, labor unions, professional and voluntary associations, and government agencies. The credit recommendations are intended to guide colleges and universities as they consider awarding credit to persons who have successfully completed non-collegiate sponsored instruction. In this way, students will be assisted in receiving academic credit for learning gained through such instruction.
