New Portfolio Development and Assessment Model in Developmental Stages

Edison College is in the process of redesigning its Individual Assessment process to increase its usefulness to students and College staff. Implementation of the new model, called "Portfolio Development and Assessment," is scheduled for July 1, 1980. College staff, led by Dr. Laura Adams, Director of Academic Programs, Dr. Paul Jacobs, Director of Test Development and Assessment, and Dr. Ruth M. McKeefery, Associate Director of Academic Programs are reviewing materials and writing new guidelines to assist students and faculty assessors in the preparation and assessment of portfolios. The term "portfolio" refers to an assemblage of materials which identify learning experiences potentially worthy of college credit and document as much as possible that the learning has taken place.

Students will be assisted by academic counselors and program advisors in developing their portfolios, which will have three broad purposes: 1) to clarify and state the student's educational and career objectives; 2) to develop a program plan including what subjects will be completed for the student's chosen degree and what methods will be used to earn credit in these subjects; 3) to prepare materials which will be used as a basis for assessment by a faculty consultant.

While the general principles and practices the College has been using in the Individual Assessment model will remain much the same, two main advantages to students will be gained through the new process: 1) students may apply for credit in as many subject areas as they have knowledge in one portfolio; and 2) students will benefit from a more comprehensive program planning service.

The College anticipates that fees for the new process will remain the same next year as this year: \$75 to apply and \$10 per credit attempted.

Details on the new Portfolio Development and Assessment model will be available from the Office of Academic Affairs after July 1.

Educational Mission to Poland

Dr. Matusak has been selected by the American Association of State Colleges and Universities as one of twelve College Presidential delegates to go on an educational mission to Poland in April.

In addition to direct talks and visits with universities, educational institutes, and Polish officials, the delegations agenda includes three seminars. The seminars will have as themes:

- Major Trends and Issues in Polish Higher Education.
- Major Trends and Issues in United States Higher Education, and the Development and Implementation of United States-Polish Educational Cooperation Programs

Dedication/Reception

Although the weather outside was cold and grey, the atmosphere within the newly renovated Kelsey Building was sunny and warm.

The foyer gleamed with bright colorful flower arrangements sent by well wishers to honor Edison's new President, Lorraine R. Matusak. The large conference room reverberated with sounds of 225 guests greeting each other. From a far corner, the delightful sound of the Trenton State College Concert Choir, directed by Dr. Ruthanne Harrison, stilled the animation of the audience.

It was February 28, 1980 . . . 4 p.m. . . . and the old historic Kelsey Building . . . was to be formally dedicated, once again as an educational institution. First in 1911 as the School of Industrial Arts, then in 1947 as Trenton Junior College and later in 1967 as Mercer County Community College, and today as Thomas A. Edison College.

Presiding over the ceremonies was Eleanor Spiegel, Chairwoman of the College's Board of Trustees. Trenton Mayor Arthur Holland welcomed the guests and recalled that his mother had attended classes in "this very same building". During brief remarks, T. Edward Hollander, Chancellor of the Department of Higher Education, noted . . . "that President Matusak often reminded him and others that there are nine New Jersey State Colleges . . . Edison and eight others." The

Chancellor ended his remarks by leading a standing ovation, recognizing Dr. Matusak as the new President of Edison College.

Delighted to be invited and speaking without aid of notes, longtime Kelsey Building advocate, Joseph P. Merlino, President of the New Jersey Senate, reviewed how the Building had been saved from the wrecking crews following citizen committee efforts and finally by a bill for renovation funds which he co-sponsored in the legislature. Pleased with the building's new look and purpose, Senator Merlino recalled that his wife, Molly, had attended art classes "in this building a number of years ago."

The keynote address, *Thriving on Paradox*, delivered by William Turnbull, President of Educational Testing Service, to the packed house, added special significance to the occasion.

Mr. Turnbull noted, "We are facing that incredible paradox: an excess of educational opportunity . . . however, if we look just at total places and total applicants, there are enough places to go round; but still, there are significant clusters of people who aren't making it to a college who want to be there."

President Turnbull summed up his address, "My main thesis today is quite simple. It is that paradoxes abound on the educational scene and that they may work to the advantage of the non-traditional institution. In the middle of educational plenty we have a scarcity of places for some people, and they are predominantly people for whom the examining college, stressing independent study, would seem to offer particular advantages. The passive virtue of access may be attained only through the active policy and practice of outreach. And, adherence to educational standards, the loss of which may well become a preoccupation of educational pundits in the years ahead, is likely to be most readily provable in the least traditional institutions."

In short, the future will have its quota of problems and contradictions. We are here today to salute a significant step into that future by an institution that seems especially well designed to help solve those problems and to draw new strength from those contradictions. Thomas A. Edison College has always been ready to cope with educational inconsistencies by innovating. Now, I believe, those innovations place this institution in a position to contribute uniquely to education in the coming years, not in spite of the paradoxes those years will present, but because of them."

Following President Turnbull's address, and while suffering from laryngitis, President Matusak, nevertheless spoke to the crowd with animation. Obviously delighted with the day's events, she noted that she had long admired Edison College from afar and was indeed happy to be here as President. She added that future plans for the College include, increasing the visibility of Edison on state and national levels, developing more outreach programs for minorities and women, and establishing alliances with New Jersey State, Community and Independent Colleges.

Eleanor Spiegel ended the formal portion of the program by presenting a key to the Building to President Matusak. Mrs. Spiegel added that . . . "Edison College is what it is and where it is today because of the dedication of many persons . . . including the Chancellor, College staff and trustees." She cited, ". . . former Trustee Chairmen, Jonathan Thiesmyer and Richard Pearson, and founding President, James D. Brown, Jr. for their efforts and achievements in obtaining this Building, dedicated today, as a permanent home for the College."

Following the dedication program, guests enjoyed a gala reception hosted by Chancellor Hollander and Edison's Board of Trustees recognizing and honoring President Lorraine R. Matusak, as the 2nd President of Thomas A. Edison College of New Jersey.

Institutional Self-Study for Reaccreditation Begins

Steering Committee Named

On March 25, Dr. Robert Kirkwood, Executive Director of Middle States Association of Colleges and Schools conducted a workshop to assist College personnel with the planning process for the required Institutional Self-Study for reaccreditation.

President Matusak commented on the Self-Study, "I look forward to the 18 months in which we will carefully study what we do well and what we can improve for the benefits of our students and our staff. A guiding force in the development of the Self-Study is the Steering Committee. I have asked the following staff to serve on this extremely important committee . . . Dr. Ruth McKeefery, coordinator of the committee and Dr. Arnold Fletcher, ex-officio; Frederick Gruel, Paul Jacobs, Dennis Smith, Michele Ferriera, Louise Perkins, Tom Streckewald, Jim Ratigan and Mary Skelton. In addition two trustees, two students and two members of the Academic Council will also be appointed to serve on the committee."

Proposals Clear 1st Hurdle

In January, members of the College staff prepared and submitted two proposals to the Fund for the Improvement of Postsecondary Education (FIPSE).

Drs. Laura Adams and Dennis Smith submitted a proposal for a "New Jersey Statewide Testing and Assessment Center", and Dr. Paul Jacobs submitted a proposal titled, "The Identification of Students Who Will Profit From Math Anxiety Reduction Classes."

Following reviews in the preliminary round, both of Edison's proposals were selected to be among the 350 finalists and the presenters were invited to prepare and submit final proposals.

The Fund received over 1,780 preliminary proposals. From the 350 finalists, the Fund will make 85 awards.

College Begins Flexible Hours

Beginning with the week of May 5, Edison College will increase the number of daily hours that offices will be open in an effort to augment staff availability to students.

College offices will remain open weekdays from 8 a.m. until 6 p.m. All college personnel will continue to work the normally required hours each week, however, more flexible scheduling will be instituted.

Garnett's Presents Workshop

In the course of its seven year history, Thomas A. Edison College has expanded rapidly. The College developed a compliment of external degree programs which have become a national model. The rapid growth of the College can best be illustrated by comparing the student body of 400 at the end of the first year to the present total of over 4,500 actively enrolled students.

Although such rapid growth has had overwhelmingly positive effects, it has also created problems. Procedures which were perfectly adequate for 400 students are no longer adequate for a student body ten times larger.

Consequently, President Matusak, acting on advice from the Executive and Advisory Committees, determined it necessary to re-examine and streamline current procedures. This streamline involves changes which can be made immediately followed by changes which rely on electronic data processing when additional financial resources are located.

In order to begin the process of examining our procedures, President Matusak invited Dr. Robert Garnett, Executive Assistant to the President for Institutional Planning at the University of Evansville, to present a workshop to the Edison staff on an Organizational Approach to Development and Implementation of a Management Information System.

Objectives for the workshop were to enhance awareness and increase understanding of Edison staff regarding need for review of information systems and the significant role each employee has in such a project. The overall objective is the improvement of services to enrolled students.

A direct result of Dr. Garnett's workshop was the formation of the Implementation Committee. The Committee which has the strong support from the College staff has received suggestions and feedback from all levels of the staff. Chaired by Dr. Dennis Smith, the Committee is analyzing the systems, processes and procedures by which the various college units function, and recommending changes which will streamline and increase the overall efficiency of the various offices.

Basic Skills

Beginning this spring, **Thomas A. Edison College** will be requiring New Jersey residents who enroll with fewer than 32 credits already earned to take the New Jersey College Basic Skills Placement Test. This is not an admissions test. It is designed to assist students in making decisions about the kinds of courses they are prepared to take. Our use of this test is mandated by the New Jersey Board of Higher Education.

Those students who are required to take the test will receive further information about times and locations from the College. There is no charge for taking the test.

Out-of-state students who wish to take the test at New Jersey locations (they are not required to take the test) should contact the College's Office of Test Development and Assessment after April 25 for further information.

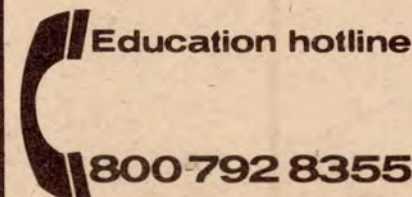

Spotlight on Students . . .

**Jane Ellen Dougherty**

Jane Ellen Dougherty of Florence, New Jersey says "All of my family members had degrees . . . my brother is a school principal, my sister has a BSN . . . and now so do I." Jane says she enrolled in Edison College a number of years ago. After transferring a few credits she had earned previously from another college, she completed her BA degree requirements though Edison by taking and passing college proficiency examinations.

Ms. Dougherty commented, "The program at Edison is very good. It suited me fine. I continued to work and earn my degree at the same time. The staff at Edison was terrific. . . . wonderful. They kept urging me on. At one point, I went through a long illness. During this time, I didn't do any work towards my degree but when I began again, I really worked hard and earned a large number of credits in a very short time."

Jane works as an administrative assistant in the Governor's Office of Employee Relations. She added that earning her BA degree through Edison was also very economical. Instead of purchasing books, she borrowed them from the library or friends and she estimated the total cost of the various exams and college courses for her baccalaureate degree at just under \$1,000.

Barbara D. Mitchell

"Edison College is absolutely wonderful! Once you're married, working, and have a family, you have other major interests and responsibilities. Most people can't go to college then . . . but with Edison, they can. I took it slow. I just recently finished my AA degree and now I'm working toward my BA. I tell you, the cost was minimal. It didn't hurt much . . . and it sure has helped a lot."



Barbara first became acquainted with Edison College after viewing a CLEP announcement on TV. Following an inquiry to CLEP, she contacted an Edison College counselor at her local library. Subsequently, she enrolled in Edison and like most Edison students, Barbara used all three methods available to her to earn her degree.

She successfully completed an Individual Assessment in Art, she took college proficiency examinations, and she transferred course work from NJIT (where she currently works in the Affirmative Action office.)

Married with a 12 year old daughter, Mrs. Mitchell added that her husband who is also in college thinks it's just great that she is pursuing her BA degree.

John David Kolb

John Kolb is self-employed. He teaches piano, guitar, organ and bass to over 95 students. He also plays professionally and has taught classes in both adult and parochial schools. In addition, John works with music students who are blind. In his free time, John and his wife travel. They have visited more than 50 foreign countries and leave for China next month.

Mr. Kolb took music lessons all his life. Whenever he could, he enrolled in various college courses. Then he heard about Thomas A. Edison College.

"Edison College was made for people like me," notes John. "I was what you might refer to as an instant degree candidate. I transferred all my college credits earned from the various colleges I had attended to my Edison transcript and . . . swish, I had more than enough to meet requirements for an AA degree."

But for John, that's just a beginning. Well on his way to a BA degree, he is currently undergoing an Individual Assessment for 21 credits in areas of music.

**Ruth Dollbaum**

"I wanted to get my degree in accounting because my employer told me I would not get a promotion unless I had a degree. That made me mad. So when I saw the briefing on Edison College listed in the Saddlebrook Adult School brochure, I made it a point to be there."

That briefing session was held in 1977 by Edison Counselor, Angela Fontan. Ms. Dollbaum subsequently enrolled in Thoams A. Edison College, and completed requirements for a Bachelor of Science in Business Administration degree *entirely* by examination. Beginning with no college credits, Ruth Dollbaum took her first exam in April of 1978 and 18 months later she passed the final test to complete a BS degree. She used both series of tests, TECEP (Thomas Edison College Examination Program) and CLEP (College Level Examination Program).

Ruth, and husband of 22 years, Edward, live in Elmwood Park, New Jersey with their five children. Ranging in age from 9 to 20, four were in their teens during the two years she pursued her degree. Laughing lightly, Ms. Dollbaum said, "The entire family helped me. I continued to work fulltime and as soon as I came home from work, I would hit the books and the kids did all the work. I didn't find the tests that difficult. I had been doing accounting most of my adult life and I knew most of it. The big difference now — with my degree in hand — is that I got the promotion, the title and the salary. It was really worth it to me — thanks to Edison College. Soon I plan to sit for the CMA (Certified Management Accounting)."
